### **Stage 2 Three Creeks Road Race**

#### **Men:**

All Riders finished within the time cut.

Congratulations on an excellent race. Littering was much better controlled and we greatly appreciate your efforts to help us retain these great courses.

Matt Wilson of Team Type I is the race leader and will wear the Yellow Jersey. Matt is also leading the KOM Competition; the Jersey will be worn by Corey Collier of HealthNet/Maxxis. Thomas Peterson of Garmin Chipotle is leading the Young Rider's competition and will wear the Red Jersey.

Butch Martin, Hagens Berman is fined \$35 for irregular feeding (4H14(b))

Rider 80, Ken Hanson of California Giant Strawberry is fined \$35 for Unauthorized feeding in the first 50K (4H14(a)).

Team Legacy Energy and Astana Team cars are relegated to the back of the caravan for stage 5 for failure to follow instructions of the Commissaires (4H15(d)).

#### **Women:**

All riders finished within the time cut.

Kristin Armstrong-Savola, Cervelo-Life Force is the race leader and will wear the Yellow jersey. Kristin Sanders, Aaron's Pro Cycling is leading the QOM Competition and will wear the Polka Dot jersey. Julie Beveridge of Aaron's Pro Cycling is leading the Best Young Rider competition and will wear the Red Jersey.

Rider 288, Coryn Rivera is fined \$35 and penalized 20 seconds for prolonged drafting (4h13(d)). Metromint Manager, Ron Van Houweling is fined \$70 for the same infraction

Riders 223 Flavia Oliveira of Touchstone, 273, Arielle Filiberti of Bend Bike'n Sport, and 293 Jane Robertson of Metromint are fined \$20 for failure to sign in (4H4(b)).

Rider 221, Kelly McDonald of Touchstone was led off of the course at Sisters and covered 1 mile less than the proscribed distance. Her time was prorated to 3:47:51

### **Stage 3 Skyliner Time Trial**

Managers must notify the Chief Referee which riders they will follow before the first rider starts in their category (noon for the women and 12:50 for the men)

Riders are reminded that bikes will be measured. Once bikes are measured, they must remain in the custody of officials or they will be remeasured before the race starts. Please arrive in the start area at least 15 minutes before your scheduled start.

### **Stage 4 Downtown Criterium**

Riders who are out of contention will be pulled at the start line. Riders who remove themselves from the race will not be placed. All riders must complete 1/3 of the distance before being lapped to avoid time cut. Riders suffering a mishap in the final 3 laps will not receive a free lap, but will be awarded the finish time of the riders they were with when the mishap occurred. They will receive their actual place if they finish, or if they choose not to continue, they will be placed behind riders who complete the final lap.
