

## Men Stage 1 Revisions

Rider 98, David Cano, Rock Racing, had his number on upside down and was placed in the results as rider 86, finishing in 20<sup>th</sup> place, 41 seconds down in GC.

## **Instructions For Time Trial**

Riders must wear both body numbers—frame number is optional.

All riders should arrive in the start area at least 15 minutes prior to their scheduled start in order to accommodate bike measurement.

Teams will be allowed to follow any two riders. The Chief Referee must be notified by 9:00am as to which riders will be followed. Follow vehicle should be staged at the start at least 5 minutes prior to scheduled start.
